terms and conditions :-

1. The State Government will not bear any financial liabilities for
the school at present or in future.
2. The school will not enhance tuition fees without prior approval of
the State Government in writing.
3. The school will pay its teaching and non-teaching staff emoluments
at a rate which will not be less than those of their counterparts in
similar Institutions of this State.
4. 10% of the students of the new admission the school will be allowed
in the school in each academic year on the recommendation of the
School Education Department and 50% of such students will be allowed
to pursue studies in other affiliated schools.
